Each performance right entitles the holder to acquire 1 fully paid ordinary share in the company for no cash consideration, subject to the satisfaction of the following performance conditions (and subject to adjustment for bonus issues, rights offers and other share capital reconstructions):

- For 50% of the performance rights, the performance condition is based on the increase in the company's earnings per share¹ (EPS) for the financial year ending 31 July 2021 (FY21) as compared to the EPS for the financial year ended 31 July 2018 (FY18). If EPS increases by 75%, half of these performance rights will vest and if EPS increases by at least 100% all of them will vest and if EPS increases by between 75% and 100% a commensurate proportion of the performance rights will vest.
- For the other 50% of the performance rights, the performance condition is based on commercial sales of new competitive products for FY21 measured against certain benchmarks.

In the case of performance rights that have been granted to the company's managing director, the company is required to satisfy any entitlement to shares underlying these performance rights by arranging to buy the shares on-market unless the company obtains shareholder approval and otherwise satisfies the ASX Listing Rules to satisfy the entitlement by issuing shares.
